The International Commission for the Evaluation of the Crimes of the Nazi and Soviet Occupation Regimes in Lithuania

Seimas adopted a Resolution on the 75th Anniversary of the End of World War II in Europe and the Victory against Nazism

Emanuelis Zingeris, Chairman of the International Commission, Member of the Seimas, Signatory of the 1990 Act of the Re-Establichment of the State of Lithuania, is the initiator of the Seimas resolution.

Noting that in 2020 the world marks the 75th anniversary of the end of World War II, the most brutal global armed conflict in the history of humanity, which claimed tens of millions of lives, the Seimas invited the global academic community and civil society to continue investigating the crimes against humanity committed by totalitarian regimes, examine historical facts and spread the truth to prevent any tragedies of this scale from happening ever again.

The Resolution expresses respect for those who fought against Nazism and condemns the historical revisionism and disinformation that the Russian Federation has employed to deny the role of the Soviet Union, as one of the key instigators of World War II, in an effort to shift the blame on the victims of the aggression and justify the Molotov-Ribbentrop Pact and its secret protocols of 1939.

On 25 May the International Day of Heroes of the Fight against Totalitarianism was marked in Lithuania for the first time. That day, Polish officer Witold Pilecki was honored in Užupis in Vilnius. Polish officer Witold Pilecki fought against both totalitarian regimes, i.e. Communism and Nazism.

On 25 May members of the European Parliament Rasa Juknevičienė and Andrius Kubilius, Polish Ambassador to Lithuania Urszula Doroszewska, Chairman of the International Commission, Member of the Seimas Emanuelis Zingeris and other members of the Seimas, Ronaldas Račinskas, Executive Director of the International Commission, representatives of Vilnius City Municipality commemorated the story of Witold Pilecki at the house in Užupis, where the Pilecki family had lived.

On 14 June the Day of Mourning and Hope will be commemorated in Lithuania. This year the Secretariat of the International Commission is initiating commemoration events "The Kite of Hope". The kite as a symbol is being connected with the idea of hope.

Since 2004 the Secretariat of the International Commission has been inviting general education institutions to mark this date and to organize commemorations in local communities, Lithuanian towns and boroughs.
